#### Catering Rules and Regulations

We take pride in history, restoration and use of Rum River Barn and Vineyard. This is a privately held property. For that purpose, in light of back-to-back events, and to adhere to the conditional use permit detailed by Morrison County, we require your cooperation with the following:

- 1. The event holder is responsible for managing food and beverage services.
- 2. All alcohol service during the Rum River Barn and Vineyard event must end no later than 12:00am.
- 3. Alcohol may not be consumed in the parking lot or in vehicles.
- 4. No alcohol service to minors.
- 5. The Rum River Barn is NOT equipped with a kitchen. Water is available both inside and outside the barn.
- 6. The caterer/liquor provider is responsible for cleanup of all cans, bottles, cups, glassware, silverware, plates, and drinks provided. All waste must be placed into the on-site dumpster.
- 7. Trash bins need to be emptied when they are full. The full garbage bags must be taken to the dumpster by the garage.
- 8. Bar tenders/liquor provider/caterers must bring their own bucket to pour excess drink waste into when preparing drinks.
- 9. Any extra ice/drink waste must be disposed of in the field away from grounds. Excess ice/drinks waste must not be left nor disposed of on grounds.
- 10. The bar area and catering area needs to be left in clean condition at the end of the event. Please respect the grounds: pick up all food, mop and pick up all spills, papers, utensils, and any other garbage before you leave.
- 11. No smoking inside any building. Cigarette butts must be placed in a receptacle.
- 12. If using electricity, please do not exceed 15 amps on each outlet.
- 13. Respect our parking guidelines. Arrangements may be made for liquor provider/caterer vehicle unloading or specialty parking.
- 14. All equipment, decoration, supplies, and rental equipment must be removed immediately after the event, unless arrangements have been made with the coordinator prior to the event.
- 15. We require licensed food caterers and bar tender/bar service.
